This was the year of scale-up with District Water Quality Platforms across 10 districts in 8 states of India, affected with Fluoride and Arsenic problems.

"

Prime among this scale-up efforts are the Rehabilitation efforts in Nalgonda now reaching to an entire block of Bagepalli. A unique programme in Nalgonda has been developed with the Anganwadi department to reach all villages (1100) of the district with Safe water testing and nutritional enhancement.

Another bright example is that of Buxar in Bihar, where the District platform for Arsenic is now recognized by the State health department. This has led to larger recognition of training of health workers and Arsenicosis detection.

# Rajasthan Government Partnership

### **INREM** Facts

We are a people and nature-first organization using new technologies making us future ready. Join us to build our dreams with you !

In the year 2021-22, the government partnership along with UNICEF-Rajasthan, focused on scaling up of the Integrated Fluorosis Mitigation to 15 districts of the State. A multi-pronged approach towards mitigating Fluorosis and keeping communities living in fluoride habitations safe is required. The IFM approach is highly relevant for Rajasthan, especially considering the sheer number of fluoride affected habitations across the State. In order to take this approach to 30 Districts under NPPCF, a necessity of a platform to discuss and streamline the on-going efforts made by related departments was felt. This led to the formation of District Fluorosis Mitigation and Coordination Committee (DFMCC) in 30 Districts under NPPCF. These District Platforms will be conducted under the chairpersonship of the District Collector of each District and the Health Department has been appointed as the nodal authority for the same.

The formal procedural requirements for the formation of DFMCC stands completed, and will be formed in each District once the final order is issued by the Administrative Reforms Department. Moreover, the budgetary allocation under NPPCF in PIP till 2024 ensures the continuation of the Committee.



Our growing partnerships with state and national government is building INREM to be an organization contributing to nation building !

Growing from Jhabua

INREM envisaged and planned this programme in 2017-18 along with the Azim Premji Foundation (APF), it was in parallel involved with such a similar approach (though with different programme trajectories, in 4 other locations across states with a similar problem of Fluoride, but with a different problematique of Fluorosis, that is present in varied geographies and social/economic conditions.

This wider programme has been supported by UNICEF, European Union (EU) and other partners, and is primarily based on these two above goals. Recently, INREM has also widened its geography and focus to such Arsenic affected areas of Bihar and Assam - the problems being different, but the larger questions being the same.

# Enabling Water quality solutions at Scale

### **INREM** Facts

Our well rounded programmes work with Water, health, nutrition, Sustainability and other streams bringing them together into our work !

Water Quality Champions is a programme that emerged in this year as a response to the challenge of Jal Jeevan Mission (JJM) and ensuring Safe water to every household by 2024.

"

This programme inducts 100-150 strong cohorts every month who undergo a motivational experience of 9 online sessions, having 22 interactive modules on Water Quality Management (WQM).

Trainers have emerged from this programme who have continued and scaled up the effort. After the programme, participants can be part of a lifelong Guided Mentoring offering that helps solve problems collectively.

This effort of INREM has now expanded to 23 states and 950 champions who are now expanding our reach to 200+ districts of India.



## **Other Programmes**

INREM Cares was launched this year as a response to growing impact of the pandemic and need for collective and coordinated action.

Ooloi labs helped us to put up the platform and we got support from multiple agencies and crowdfunding, especially Azim Premji Foundation (APF) that generously made a grant support of INR 1.1 crores with focus on Jhabua and Ali Rajpur districts. We could reach out to more than 1 lakh population and help with basic nutritious food, medicines, and hygiene support during this critical time.


We developed further partnerships during this year with International Water Management Institute (IWMI) on Solar based irrigation, with Water Harvest on rainwater harvesting and the ANT with focus on Water quality mitigation.

Our regional programmes developed numerous partnerships, with Gram Vikas in Odisha being one important such partnership.


